# GCT BUS AND DRIVER HIRE PRICING STRUCTURE FOR GROUP TRIPS

This pricing information is to serve as a guide in costing out group outings for GCT. It highlights pricing structures for groups or organisations approaching GCT to provide transport services for their groups to attend social outings and/or hire a bus and driver to drive their group to a desired destination and back for the day for the purpose of enriching the lives of their clients. The price structure separates bus and driver hire arrangements from arrangements where there might be clients on board who meet the eligibility criteria for a funding stream in which GCT is receiving, such as CHSP



**Bus and driver hire**

**Weekday rates (between 8am and 6pm)**

- \$365 minimum charge which includes the first 3 hours and 100kms of travel for a 23 seater bus. \$55 per hour and \$2.00 per km thereafter.
- \$325 minimum charge which includes the first 3 hours and 100kms of travel for a 13 seater Van. \$55 per hour and \$1.60 per km thereafter.

**Saturday rates (between 8am and 6pm)**

- \$413 minimum charge which includes the first 3 hours and 100kms of travel for a 23 seater bus. \$71 per hour and \$2.00 per km thereafter.
- \$373 minimum charge which includes the first 3 hours and 100kms of travel for a 13 seater Van. \$71 per hour and \$1.60 per km thereafter.

**Sunday rates (between 8am and 6pm)**

- \$464 minimum charge which includes the first 3 hours and 100kms of travel for a 23 seater bus. \$88 per hour and \$2.00 per km thereafter.
- \$424 minimum charge which includes the first 3 hours and 100kms of travel for a 13 seater Van. \$88 per hour and \$1.60 per km thereafter.

- \* Prices will incur 10% GST
- \* All bus hires must be with a driver hire
- \* Costs are calculated from the GCT depot and back to the GCT depot
- \* Hires outside of the stated times attract a 15% loading applied to the driver rate for the entire hire
- \* **Wheelchair accessible vehicles available at no extra cost, however, seating capacity is reduced**

**Bus and driver hire with subsidy eligible clients on board**

**Rate per person for weekday trips (between 8am and 6pm)**

- \$15 per person for clients who are eligible for a funding stream
- \$45 per person for all other clients who do not qualify for a funding stream (full cost, package clients, NDIS)

**Rate per person for Saturday trips (between 8am and 6pm)**

- \$25 per person for clients who are eligible for a funding stream
- \$50 per person for all other clients who do not qualify for a funding stream (full cost, package clients, NDIS)

**Rate per person for Sunday trips (between 8am and 6pm)**

- \$30 per person for clients who are eligible for a funding stream
- \$60 per person for all other clients who do not qualify for a funding stream (full cost, package clients, NDIS)

- \* Clients accessing subsidised funding streams must go through and be confirmed as eligible by My Aged Care or deemed eligible by GCT if under 65
- \* Prices will incur 10% GST for non-eligible clients
- \* Minimum 15 clients per bus
- \* Costs quoted are based on minimum numbers per person, per bus (if an additional bus is needed, the minimum number and cost per head for that bus applies)
- \* Costs are based on a maximum 8 hour day, travelling up to 200kms in a single day
- \* **Wheelchair accessible vehicles available at no extra cost, however, seating capacity is reduced**
- \* A maximum of 1 staff member from an organisation can travel free of charge per bus as courtesy
